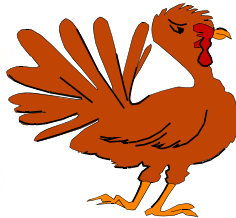

Are We On the Same Page?

I – and probably many of you -- have been to any number of meetings that were called just to make sure that “everyone is on the same page”.

This metaphor resonates for us in a way that it may not for most people. In fact, I sometimes wonder if it originated with a hard of hearing person.

Handouts do help keep us on track. But have you ever had the experience of spending most of your time and attention just trying to keep it open to the right page? Me, too. I watch for key words, sneak furtive glances at others’ papers, and try to find a match in my own hand without rustling the pages too much. After a couple of minutes I repeat the process, trying to look as if I know exactly what we are talking about. I can spend the entire hour doing this, feeling a great sense of pride and accomplishment just for managing to stay on the same page.

Metaphorically though, I might as well be reading a different book. Trying to keep the right page in front of me leaves me no time to think about what’s actually on it, much less its

meaning for my work. Such is our life among hearing people, unless we learn – and they learn – how to accommodate.

Not all accommodations are high-tech. Many people, after attending their first HLAA meeting, have commented on how they felt fully accepted. You can ask people to repeat things, talk loudly, and be thought a perfectly nice person even when you fail to reply to someone’s greeting. We’re here because we can be who we are – hard of hearing people – and not be left out of the community.

Look around you, and you will see your accommodations: your friends at HLAA. Here, we are truly on the same page, due to our common understanding. We are even literally on the same page, because of CART. And because we don’t have to work so hard at it, we are free to think about how things apply to us. We’re free to find things meaningful.

I like it that way. I hope you do, too.

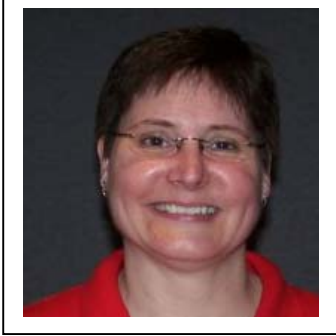

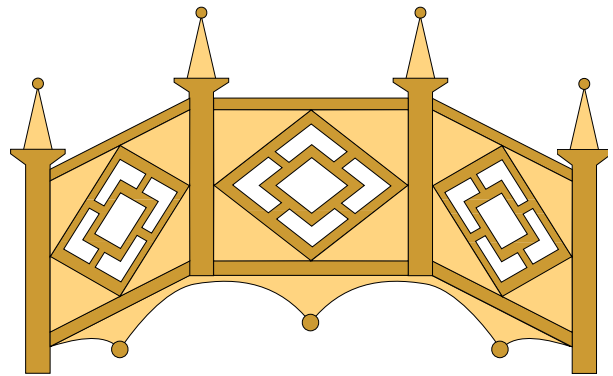
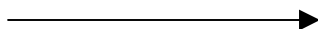
Comment from our readers

Last month in the Bits and Pieces column, an item of interest was a HA that appeared to have not too much to offer, and in response we have a comment from Paul Tuveson from Midwest Hearing Aid Systems who wrote.

Your little blurb on the Zon hearing aid which has no t-coil or no way to interface with assistive listening devices.

Just a little note regarding that: The hearing aid industry has changed somewhat in the last few years as to fitting strategies and features. Hearing aids are getting smaller and smaller due to better feedback controls by the manufactures. Also hearing aids with the right feature can work better with the telephone. For most people this has been a blessing. This however does not translate to be a positive situation for everyone as typically the new phone feature cannot be used with assistive listening devices. The consumer needs to make this problem known when buying a new hearing aid.

Unfortunately this is a bad oversight by many people selling hearing aids as the numbers of people who use assistive listening devices are few in comparison to the number who don't need it or won't use them. Bottom line is this. Many new models, many new features, please make it clear what you want the hearing aid to do for you when you're shopping for a new aid. Should you be uncertain as to what you are getting, please speak up. What will be next? Probably Blue Tooth expansion (it's out, but somewhat limited). You'll be able to sit in your chair, push a button and it will send a signal directly from the telephone to your hearing aid. Push another button and you can pick up the signal from the television for starters. Will you be able to push a button and have your spouse deliver your favorite beverage? No I doubt that one will ever be programmed! You're on your own there! Paul can be reached at

SPEAKING OUT and EDUCATING

Our own Hunter Sargent did just that. In the Minneapolis StarTribune of October 20th 2008, an article was published regarding to the brutal beating of a young man who has fetal alcohol syndrome. This sad and revolting incident has drawn the attention of the community in general, and the Minneapolis paper carried a number of stories on the case.

Entitled “ *Too quick to trust those who pretend to care*”, the piece opened with Hunter’s name. Even though he does not know the gentleman personally, Hunter relates that “ hearing the news of his brutal beating and torture stung as if he had received the blows himself.” Those are very powerful words. He further talks about the specific vulnerabilities of people who have fetal alcohol syndrome. They tend to bond and trust easily which leaves them wide open to all kinds of abuse as well as to the betrayal of those in whom they put their faith. What could be worse? Hunter believes that the broken bones and the burns will eventually heal, but that the psychological scars go so much deeper than the actual physical wounds.

There is no doubt that Hunter can relate to the young man who was so terribly wronged. He spoke out publicly on his behalf which takes a great deal of courage and inner strength. Whenever we voice our opinion, whenever we take up a cause, we also reveal something about the soft spots within our own beings and souls.

In the end though, this is not only a story about speaking out. For those who read the article it also became quite an educational experience. Hunter does talk to groups on the realities and challenges of fetal alcohol syndrome. That way, *he is not only an advocate but also an educator.*

On behalf of HLAA TC, I congratulate Hunter officially on his efforts to speak for those who have little or no voice. We want to let him know how proud we are to say that he is one of us. At HLAA TC *we do not pretend to care.* We honestly do care and value trust highly.

I close with one of my favorite quotes by Dr. Martin Luther King Jr.:” Our lives begin to end the day we become silent about things that matter.” Yeah, Hunter!!

Editors Note:

Hunter Sargent was also quoted in the Access Press Newspaper in the Sept. 10, 2008 issue under “Intellectual Disability NOT Funny.” It dealt with offensive language being hurtful and cruel to people with disabilities. Hunter is a self-advocate and board member for the Arc of Minnesota. He is also an HLAA TC member.
